Statement of the Board Chair Regarding Items 6.8, 6.9, 6.10 and 6.11

The Board received the attached letter from Aaron E. Doyle, of the Doyle Law Firm, dated January 2, 2022 that alleges violations of the Brown Act by this Board, namely that during that meeting, the Board called for public comment and on a number of items, despite raising his "hand", Mr. Fatheree was not unmuted so that he could address the Board or make public comment.

The Board has been, and remains committed to transparency in its service to the public, and is continually working to ensure it complies with all laws and regulations, including the Brown Act. Accordingly, the Board takes any accusation of a violation of the Brown Act seriously, and the primary purpose of this meeting is to address the alleged violations from Mr. Doyle, by performing cure actions as prescribed by statute.

The Board has looked into this matter. The practices that the Board employs to take public comment via Zoom are similar to those employed by other jurisdictions, including at least one city in the Tahoe basin.

Nevertheless, tonight we will propose to take certain actions to cure or correct the violations alleged in Mr. Doyle's January 2, 2022 letter, and to cease and desist from preventing or obstructing any member of the public from commenting during the time the public is invited to address the Board or make public comment regarding any item that is on the agenda for the meeting, before or during the Board's consideration of the item, or on any item of interest to the public that is within the subject matter jurisdiction of the Board, subject to the applicable requirements and limitations of the Ralph M. Brown Act regarding public comments at meetings.

I am recommending that the Board cure and correct the alleged violations by (i) rescinding and readopting the actions on the November 15, 2021 agenda, (ii) updating its standard agenda language to provide additional instruction to the public about how to be recognized, and (iii) providing two training / rehearsal sessions open to the public outside of Board meetings to learn about and practice being recognized at public meetings.

The fact that the Board takes the proposed actions to cure or correct its prior actions shall not be construed or admissible as any evidence of a violation. (Gov't Code § 54960.1(f).)
