- 7.5 Resolution 2022-009 authorization to continue remote meetings. Does the Board want to continue remote meetings? Discuss the different types of meetings; remote, hybrid, or in person. Recommendations: Discuss, approve resolution 2022-009 or other meeting form, and provide direction.
- 7.6 AB38 Defensible Space Inspection. AB38 requires a home inspection upon the sale of a home in a high or very high hazard severity zone. The Board needs to select a member to do more research on AB38 and report back at the July meeting on requirements and how it affects the District.

  Recommendations: Discuss, appoint, and provide direction.
- 7.7 Receive Monthly Report from Chief Frank including the number of calls for service in the last month, equipment, station, and personnel status, information from Chiefs Association meeting, and any related issues.
  - Recommendations: Receive update, discuss, and provide direction.
- 7.8 Forest Service Contract. Chief Frank to provide current status of contract with Forest Service for wildland fires.
  - Recommendations: Receive update, discuss, and provide direction.
- 7.9 Plumas County Mutual Aid Agreement for Emergency Services. Chief Frank to provide information on the renewal of the Mutual Aid agreement between Plumas County Emergency Services agencies. There will be a very short time frame for review and signing of agreement, a future Special Meeting could be needed on this agreement.
  - Recommendations: Review information and requirements, discuss, decide on how to address the short turn around for approval, and provide direction.
- 7.10 Surplus Excess Scott Self Contained Breathing Apparatus (SCBA). The District has 25 Scott SCBA packs and 18 bottles from the purchase prior to the grant for the new SCBA's awarded, that are excess. Chief Frank request authorization to be able to donate the SCBA's to a fire district that is in extreme need and/or sell to help offset the cost of the grant matching funds.

  Recommendations: Receive information, discuss, approve surplusing excess Scott SCBA's by donation and/or selling, and provide direction.
- 7.11 Surplus Survive Air SCBA's. The District has several Survive Air SCBA's. Survive Air parts or complete packs are no longer available; however, some districts still have them. Recommend authorizing making the Survive Air SCBA's available as parts to the districts that still use Survive Air SCBA's. Recommendations: Discuss, approve the surplusing of Survive Air SCBA's for parts only to other districts, and provide direction.
