Ordering Formation of Eastern Plumas Rural
Fire Protection District of Plumas County

WHEREAS, a petition for the formation of a fire protection district, with the proposed name of Eastern Plumas Rural Fire Protection District of Plumas County, was heretofore filed with the Board of Supervisors of Plumas County, pursuant to the provisions of the Fire Protection District Law of 1961, Health and Safety Code Sections 13801 et seq.; and

WHEREAS, the proposed district lies entirely in the unincorporated area of Plumas County, and the exterior boundaries of the territory proposed for inclusion in the proposed district are as set forth in Exhibit A and are as shown on map designated Exhibit B, both of which are attached hereto and incorporated herein by reference; and

WHEREAS, said Board of Supervisors heretofore referred said petition to the Local Agency Formation Commission of Plumas County for consideration; and

WHEREAS, by Resolution No. 75-03 said Commission approved the formation of said fire protection district and authorized the Board of Supervisors to proceed with the formation thereof pursuant to Health and Safety Code Sections 13801 et seq., without election, under the authority of Health and Safety Code Section 13825(c); and

WHEREAS, the Local Agency Formation Commission has determined the formation of said district is exempt from the California Environmental Quality Act and has filed a negative declaration certifying said determination; and

WHEREAS, at the time and in the form and in the manner provided by law, the Clerk of said Board has given notice of the date, time, and place of a public hearing by this Board of Supervisors upon said petition, to be held at 1:30 p.m. on September 10, 1975, in the Supervisors Room, Courthouse, Quincy, California; and

WHEREAS, a public hearing by this Board of Supervisors was duly held upon the date and at the time and place specified by said notice of public hearing; and

WHEREAS, at said hearing this Board of Supervisors heard all interested parties desiring to be heard and considered said petition and all other relevant evidence and information presented at said hearing; and

WHEREAS, the Board of Supervisors of Plumas County deems it appropriate to approve the formation of the Eastern Plumas Rural Fire Protection District of Plumas County;

NOW, THEREFORE, BE IT RESOLVED that said Board does hereby find and order as follows:

FINDINGS

1. That the facts recited above are all true and correct.
2. That the petition on file herein has been signed by registered voters in the proposed district equal in number at least to 51 percent of all the votes cast within the proposed district for all the candidates for Governor at the last gubernatorial election.
3. That said petition and notice of hearing are sufficient and comply with Health and Safety Code Sections 13801 et seq.

3. Five members of a board of directors of said district shall be elected pursuant to Part 2.7, Fire Protection District Law of 1961, Health and Safety Code Sections 13801 et seq.

The foregoing resolution was duly passed and adopted by the Board of Supervisors of Plumas County at an adjourned regular meeting thereof held on the 10th day of September, 1975, by the following vote:

Commencing at that certain monument identified as CM7-72, as shown on the map entitled "Survey of a Control Line for State Highway Purposes" recorded April 14, 1966, in Book 3 of Record of Surveys at page 61, Plumas County Records; thence along said Control Line N. 55°38'30" E., 577.60 feet to that certain monument identified as CM7-73, as shown on said map; thence, leaving said Control Line, N. 64°16'52" E., 476.30 feet to a point hereinbelow referred to as Point "A"; thence, N. 01°54'52" W., 108 feet, more or less, to the south line of the said N. 1/2 of the NE 1/4, being the TRUE POINT OF BEGINNING of this description; thence, continuing N. 01°54'52" W., 20 feet to a point from which said Point "A" bears, S. 01°54'52" E., 128.00 feet; thence, N. 44°59'12" W., 140.27 feet; thence N. 68°58'18" W., 96.00 feet; thence S.

72°26'02" W., 186.07 feet; thence, S. 89°42'58" W., 82.77 feet;

353.78 feet; thence, N. 86°03'00" E., 439.37 feet; thence, N.
03°57'00" W., 1000.00 feet; thence, S. 86°03'00" W., 871.20 feet;
thence, S. 03°57'00" E., 1000.00 feet; thence, N. 86°03'00" E.,
312.49 feet; thence, S. 37°01'24" E., 540 feet to the said south
line of the N. 1/2 of the NE 1/4; thence, along said south line,
easterly, 540 feet, more or less, to the TRUE POINT OF BEGINNING.

the NE 1/4 of Section 2, T.22 N., R.13 E., and the NE 1/4 of
